NENAHNEZAD CHAPTER APPROVES THE FINANCIAL REPORT FOR THE MONTH ENDING AUGUST 2026

WHEREAS:

1. Pursuant to 26 N.N.C. §3 (A), the Nenahnezad Chapter was certified on November 10, 1955 as a chapter of the Navajo Nation and is listed under 11 N.N.C., Part 1, §(B), the Nenahnezad Chapter is delegated the governmental authority to make decisions over local matters consistent with Navajo Laws including custom, tradition, and fiscal matters; and
2. Pursuant to 26 N.N. Section 1 (B) is vested with the authority to review all matters affecting the community and to make appropriate corrections when necessary and make recommendations to the Navajo Nation and other local agencies for appropriate actions, and
3. The Nenahnezad Chapter will continue to comply with the Fiscal Year 2026 Budget Instruction Manual; and
4. The balances of Revenue, Expenses and Total fund balance ending August 2026 was read in detail to the community members; see attached of July Statement of Revenue and Expenditures, Combine Detail report and Budget to Actual; and
5. In compliance of budget manual, the Chapter will continue to pass a monthly resolution to comply with all auditing regulations.

NOW THEREFORE BE IT RESOLVED THAT:

1. The Nenahnezad Chapter hereby accepts the Financial Report for the month ending August 2026. The financial reports are hereby attached as Exhibit A: 1.) Statement of Revenue and Expenditure; 2) Combining Balance Sheet and 3.) The Budget to Actual Statement for all fund accounts.
2. The Nenahnezad Chapter directs the upcoming Community Coordinator, Account Maintenance Specialist, Chapter Officials, and the Council Delegate to carry out the intent of this resolution.
